MR BO VESTERDORF HAS AGAIN BEEN RE-ELECTED PRESIDENT OF THE COURT OF FIRST INSTANCE OF THE EUROPEAN COMMUNITIES

Under Article 224 of the EC Treaty and 140 of the EAEC, "the Judges shall elect the President of the Court of First Instance from among their number for a term of three years".

Pursuant to those provisions and to Article 7(1) of the Rules of Procedure of the Court of First Instance, the Members of the Court have today re-elected Mr Bo Vesterdorf as President of the Court of First Instance.

First elected President of that Court in March 1998 following Mr Saggio's departure, Mr Vesterdorf was re-elected in September 1998 and in September 2001.

Mr Vesterdorf is thus starting his third three-year term as President of the Court of First Instance.

President Vesterdorf – Curriculum vitae:

Born in 1945; Jurist-Linguist at the Court of Justice; Administrator with the Danish Ministry of Justice; Deputy Judge; Legal Attaché with the Permanent Representation of Denmark to the European Communities; temporary judge at the Østre Landsret (Court of Appeal); Head of the 'Constitutional and Administrative Law' Department at the Ministry of Justice; Director at the Ministry of Justice; University lecturer; Member of the Human Rights Steering Committee at the Council of Europe, then Member of the Bureau; Judge at the Court of First Instance since 25 September 1989; President of the Court of First Instance since 4 March 1998.
