VISIT TO THE COURT OF JUSTICE OF THE EUROPEAN COMMUNITIES BY A DELEGATION FROM THE CONSTITUTIONAL COURT OF THE CZECH REPUBLIC

A delegation of twelve judges from the Ústavní soud České republiky (Constitutional Court of the Czech Republic), led by its President, Mr Pavel Rychetský, is making an official visit to the Court of Justice of the European Communities on 18 and 19 April 2005. The delegation has been received by Mr Vassilios Skouris, President of the Court, and by Mr Jiří Malenovský, Judge at the Court, and Mr Roger Grass, Registrar of the Court.

On the occasion of this visit, and after taking part in a working session with Mr Jiří Malenovský, Judge at the Court of Justice, and Ms Irena Pelikánová, Judge at the Court of First Instance, on “The jurisdiction and organisation of the Court of Justice”, the delegation has participated, with the President and Members of the Court of Justice, in various round table discussions. They related to the following subjects: “Participation and role of the constitutional courts in the context of preliminary ruling proceedings”; “Reflections at the European level on the case-law of the Constitutional Court of Germany”; and “Relationship between the system of protection of human rights before the ECHR in Strasbourg and that before the Court of Justice of the European Communities in Luxembourg in the light of the Treaty establishing a Constitution for Europe”.

The delegation has also attended a hearing in a case before the Grand Chamber of the Court of Justice.

This meeting is organised in the context of the close, ongoing relations between the Court of Justice and the supreme courts of the Member States. The Ústavní soud České republiky visited the Court in 1996 and in 1997.
