**VISIT TO THE COURT OF JUSTICE OF THE EUROPEAN COMMUNITIES BY A  
DELEGATION FROM THE CONSTITUTIONAL COURT OF BULGARIA**

A delegation of five judges from the Constitutional Court of Bulgaria, headed by its President, Mr Nedelcho Beronov, today paid an official visit to the Court of Justice of the European Communities, where it was received by the President of the Court, Mr Vassilios Skouris.

On the occasion of this visit, the delegation participated in a number of working sessions dealing with the jurisdiction and operation of the Court of Justice, in the presence of Mr Peter Jann, President of the First Chamber of the Court of Justice, and with the preliminary-reference procedure, in the presence of Mr Leendert Adrie Geelhoed, First Advocate General at the Court of Justice, and in sessions dealing with proceedings before the Court of Justice and the linguistic regime.

This meeting has been organised within the framework of the close, ongoing relations which the Court of Justice fosters with the superior courts of the States preparing for accession. A separate delegation from the Constitutional Court of Bulgaria had already paid a visit to the Court of Justice in June 2005.
