**ELECTION OF THE PRESIDENTS OF THE CHAMBERS OF THREE JUDGES OF  
THE COURT OF JUSTICE**

After having re-elected Mr Vassilios Skouris as President of the Court of Justice of the European Communities, and elected the Presidents of the Chambers of five Judges, the Judges of the Court elected from among their number, on 12 October 2006, the Presidents of the Chambers of three Judges in accordance with Article 10(1) of the Rules of Procedure of the Court of Justice.

The following have thus been elected for a period of one year: Mr Romain Schintgen, President of the Fifth Chamber, Mr Pranas Kūris, President of the Sixth Chamber, Mr Endre Juhász, President of the Eighth Chamber and Mr Ján Klučka, President of the Seventh Chamber.

In addition, on 11 October 2006, the Court appointed Ms Juliane Kokott as First Advocate General for a term of one year.
