**OFFICIAL VISIT OF THE COURT OF JUSTICE OF THE EUROPEAN
COMMUNITIES TO IRELAND**

The Court of Justice of the European Communities will pay an official visit to Ireland from Wednesday 16 May to Sunday 20 May 2007. The delegation is led by Mr. Vassilios Skouris, President of the Court of Justice and is composed of Mr. Peter Jann, Mr. Allan Rosas, Mr. Koen Lenaerts and Mr. Ján Klučka, Presidents of Chambers, Mrs Rosario Silva de Lapuerta, Mr. George Arestis, Mr. Anthony Borg Barthet, Mr. Egils Levits, and Mr. Aindrias Ó Caoimh, Judges, Mrs Eleanor Sharpston, Advocate General, Mrs Pernilla Lindh, Judge, Mr. Yves Bot, Advocate General, Mr. Jean-Claude Bonichot, Mr. Thomas von Danwitz, Mr. Alexander Arabadjiev and Mrs Camelia Toader, Judges, and Mr. Roger Grass, Registrar.

The delegation will be welcomed by The Hon. Mr Justice John L. Murray, Chief Justice of Ireland, Judges of the Supreme Court, The Hon. Mr Justice Richard Johnson, President of the High Court of Ireland and Judges of the High Court.

The President and Members of the Court of Justice, along with the Chief Justice, President of the High Court and Judges of the Supreme Court and High Court, will take part in a number of discussions over the course of the visit concerning European Community law, Irish law, and the interaction between the two.

On Friday 18 May, the delegation will meet Dr. Rory O’Hanlon, Ceann Comhairle, and will visit the Houses of the Oireachtas. In the evening the delegation will attend a dinner hosted by The President of Ireland, Her Excellency Mary McAleese.

The visit takes place in the context of the continuous relations which the Court of Justice maintains with the highest institutions of the Member States. The Court of Justice received an official visit from The President of Ireland in 2003 and from the Attorney General of Ireland in 1998.
