VISIT TO THE COURT OF JUSTICE OF HIS EXCELLENCY MR TRAIAN BĂSESCU, PRESIDENT OF ROMANIA

His Excellency Mr Traian Băsescu, President of Romania today visited the Court of Justice of the European Communities accompanied by His Excellency Mr Emil Boc, Prime Minister, His Excellency Mr George Pogea, Minister of Finance, His Excellency Mr Cristian Diaconescu, Minister of Foreign Affairs, His Excellency Mr Mihnea Ioan Motoc, Permanent Representative of Romania to the European Union and His Excellency Mr Vlad Alexandrescu, Ambassador of Romania to the Grand-Duchy of Luxembourg.

His Excellency Mr Traian Băsescu and the presidential party were welcomed by Mr Vassilios Skouris, President of the Court of Justice, Mrs Camelia Toader, Judge of the Court of Justice and by Mr Roger Grass, Registrar of the Court of Justice.
